Statewide CACFP Conference Recap

Over 100 CACFP Sponsors joined KSDE for a Statewide Conference in early November where attendees learned about leading the way in creating healthier childcare environments. Participants who attended the pre-conference training, Let's Talk About It...Grains to Ounce Equivalents, reported they felt more confident in identifying and serving whole grain-rich items as well as in their ability to calculate the grains component using ounce equivalents as a result of attending the training. Did you miss the opportunity to attend? Watch for regional spring training dates for Grains 101 where attendees will learn about calculating ounce equivalents, identifying whole grains and grain-based desserts. Training dates and locations will be announced in a future update.

All claims for reimbursement must be certified. On the claims tab in KN-Claim after you have entered a claim(s) and uploaded a for-profit roster, if applicable, click on the pencil icon on the Sponsor Claim line. Scroll down to the bottom and check the box that says "I certify...". Then click Save and Exit.

Training Opportunities

Jump Start for Centers

Jump Start for Centers is required for all new authorized representatives of centers and recommended for new support staff who provide assistance to the authorized representative. The classes are repeated through the year. The schedule and registration information is at <u>www.kn-eat.org</u>, CACFP, Training. The next class will be December 11 in Topeka. This free training class includes sessions on CACFP Administrative Integrity and Meals Done Right.

Online Professional Development Classes and Tutorials

CNW staff continue to develop new interactive online training classes and quick train tutorials that can be accessed free of charge 24/7 via the KSDE Training Portal. **CACFP Family Style Meal Service and the PY2019 CACFP Administrative Workshop are now available online**. The professional development classes offer a certificate upon successful completion which can be printed. Quick train tutorials are 5 minutes or less with no quiz and no certificate. Increasing Flexibility for Verification of For-Profit Center Eligibility in the CACFP

In a <u>Federal Register</u> notice published on October 4, 2018, USDA <u>announced</u> a proposed rule that would exempt for-profit centers from monthly verification if they annually demonstrate that at least 50 percent of children or adults served are eligible under relevant statutory provisions. Comments must be received on or before December 4, 2018.

Food Buying Guide for Child Nutrition Programs Interactive Web-Based Tool Enhancements!

On November 1, FNS released new enhancements to the Food Buying Guide for Child Nutrition Programs (FBG) Interactive Web-Based Tool. The following enhancements are specific to the Recipe Analysis Workbook (RAW) which now has the following capabilities: allow an existing RAW to be copied and easily recreated for multiple serving sizes; include the total vegetable amount with a breakdown of vegetable subgroup amounts on the meal pattern contribution statement; and create a notes section. This release also includes the addition of three preschool meal pattern charts. The Food Buying Guide Interactive Tool may be accessed at https://foodbuyingguide.fns.usda.gov/.
