## **CACFP Claims and State Year End – Important!**

April and May claims submitted and in approved status by the end of the day on June 12 will be paid and money deposited by June 16. If April or May claims are not submitted by the end of the day on June 12, payment will not be made until July due to the state fiscal year end closeout. Remember, the April claim deadline is June 29. Home Sponsors must submit May claims for Day Care Homes by 3 pm on June 12.
