All claims for reimbursement in "Approved" status by 5:00 pm on Thursday, March 7, 2024, will be directly deposited on Friday, March 15, 2024. Additionally, any claims in "Approved" status by 5:00 pm on Tuesday, March 26, 2024, will be directly deposited on Friday, March 29, 2024.

Claim Update – Home Sponsoring Organizations Only

February claims must be in "Pending Approval" status by 3:00 pm Monday, March 25, 2024, so that payments can be directly deposited on Friday, March 29, 2024.

USDA Guidance

Revised Crediting Tofu and Soy Yogurt Products in School Meals, CACFP 02-2024

This memorandum provides updated guidance on crediting tofu and soy yogurt products in the Child and Adult Care Food Program and extends previous guidance on crediting tofu and soy yogurt products to the Summer Food Service Program, as well as to the infant meal pattern in the Child and Adult Care Food Program.

Questions and answers providing guidance for procurement and inspection requirements for local meat, poultry, seafood, game, and eggs have been revised.

USDA's Team Nutrition initiative is excited to announce the availability of *It's Breakfast Time! Child and Adult Care Food Program (CACFP) Breakfast Menu Planner for Children 3 Through 18 Years of Age* in English and Spanish.

Additionally, the revised version of the *Let's Make a Snack! Child and Adult Care Food Program (CACFP) Snack Menu Planner for Children 3 through 18 Years of Age* is now available in English and the Spanish version is available for the first time. These menu planners are an excellent training resource for CACFP operators and cover creditable and non-creditable foods at breakfast and snack, interactive meal planning activities, sample menus, and quick and easy recipes.

Summer Food Service Program (SFSP) 2024

Summer Meals Programs are designed to fill the nutrition gap that occurs in summer and make sure children can get the nutritious meals they need. Many sites provide not just meals, but educational, enrichment, and recreational activities that help children continue to learn and stay safe when school is not in session. Summer meals act as a "magnet" to draw children to activities and activities draw children to summer meals. Meals can be served at a variety of locations, including schools, camps, parks, recreation centers, YMCAs, Head Start Centers, Community Action Agencies, Boys and Girls Clubs...and many other places.

All new and returning sponsors **must have at least one representative complete** this administrative training in order to operate the SFSP in summer 2024.



Summer Non-Congregate Meals Training – March 28

If your sponsor is planning to offer non-congregate meals through the Summer Food Service Program (SFSP) or the Seamless Summer Option (SSO) in summer 2024, **at least one sponsor representative must attend the Summer Non-Congregate Meals Training** on Thursday, March 28 from 2:00-3:00 pm. The training will be offered live via Zoom at the following link: https://ksde.zoom.us/j/89544189590?pwd=ckVtSVZTWlluUDJ6Y3JreTQ5RGJtZz09 (Passcode: 923074). Non-congregate meal service is defined by USDA as "a food service at which meals are provided for children to consume all of the components off site". This training will explain requirements for operating non-congregate meal service sites based on new USDA guidance. For those unable to attend the live training, a recording will be made available on the KSDE Training Portal at a later date.

Message to Child Care Facilities from the Kansas Office of the State Fire Marshall

The Office of the Kansas State Fire Marshal (OSFM) is dedicated to ensuring all buildings in the State of Kansas are safe for those who occupy them. This is done through the review of plans and by conducting in-person inspections across the state. They also partner with some local fire departments who have established inspection programs on these plan reviews, license amendments, and annual inspections. Some of you may have had your inspections conducted by local fire department personnel in the past, however as our state and local fire codes have grown farther apart, there have been more instances of conflicting information being given to project managers and childcare providers.

Effective January 2024, staff from the Office of the State Fire Marshall will be conducting all Child Care facility approvals and annual inspections throughout the state. OSFM will be responsible for handling all Fire and Life Safety Inspection for licensing requirements for home daycares, pre-schools, and Child Care centers at the state level. This will streamline the application and licensing process while providing more consistent guidance to childcare providers.

How does this change affect you?

- If you are a newly licensed Childcare Center, Preschool, After School program (any program but Home Day cares) or if you are amending your license with KDHE, you will now be responsible for providing OSFM with a code footprint from a licensed Kansas architect/engineer for approval. All documents must be submitted to prevention@ks.gov. Please refer to the OSFM website for further details – https://firemarshal.ks.gov/365/Childcare
- If you are an existing Child Care Center, Preschool, After School program (any program but Home Day cares) and you are awaiting your annual inspection for the year, you will not need to take any action since the OSFM already has you in our system and will contact you directly to schedule your inspection at the appropriate time.
- New Home Day care providers: KDHE will provide your information to the OSFM and they will schedule your initial fire code inspection.
- Existing Home Day care providers: Nothing will change for you unless you amend your license. If you already have been approved, you will not need to receive an additional inspection from the OSFM.

Farm to ECE Institute Applications Available Soon

The Heartland Farm to Early Care and Education (ECE) Institute is a year-long program for CACFP sponsors to initiate or expand Farm to ECE efforts. The Institute connects the cafeteria, classroom, and community to build strong and sustainable Farm to ECE programming. Applicants will form a team of 3-5 people with interest in stake in Farm to ECE goals.

This program is formally led by the Kansas Department of Education, Missouri Department of Elementary and Secondary Education, and the Nebraska Department of Education to share ideas and resources. A kick-off retreat will be held November 13-15 at Lied Lodge in Nebraska City, Nebraska. Following the retreat, applicants will work with a coach to provide support, technical assistance, and education for Farm to ECE projects.

The Institute model is designed by Vermont FEED, who has been hosting a Northeast Farm to School Institute for over a decade. Kansas Breastfeeding Coalition March "Message of the Month"

DID YOU KNOW? Child care providers participating in CACFP receive reimbursement for meals and snacks when an infant is provided pumped breast milk or is breast/chestfed on site, even after the child's first birthday! CACFP best practice encourages persons to supply breast milk for their infants in childcare and offer a quiet area that is comfortable and sanitary for persons who come on site to breast/chestfeed. Breast milk can be used to meet the fluid milk requirement in the CACFP program for children over 12 months of age. Nearly 90% of families in KS choose to #breastfeed and they are looking for breastfeeding supportive child care. Become a "Breastfeeding Friendly Childcare Provider."
