2025 Certification

Thank you to those Sponsors who have submitted their 2025 packets for certification in KN-CLAIM. Consultants are currently working through certification documents to approve Sponsors for the 2025 program year in the order they were received. If certification information has not been submitted, sponsors can find instructions for certification at https://cnw.ksde.org, CACFP, Program Certification. To participate in CACFP for the 2025 Program Year, beginning October 2024, Sponsors must complete program certification requirements as soon as possible to allow sufficient time for review by KSDE consultants. Sponsors cannot claim meals in the 2025 program year until Program Certification is complete and approved by KSDE.

October Claim Reminder - Centers Only

Centers must report the number of free, reduced price, and paid participants on their October claims. The number of participants in each category is reported in the "Center Income Eligibility Categories" (IEC) section of the Center Claim. Sponsors are required to upload the IEC summary into KN-CLAIM in October and any other month that reported numbers are changed. An Excel version of the Income Eligibility Categories Summary template is available at https://cnw.ksde.org, CACFP, Administrative Handbook, Chapter 12 Claiming Reimbursement.

Reminder: When the claiming percentages are being established for the year, the IEC Summary must only include those participants who have complete and valid enrollment forms on file AND ate a meal/snack in the month of October.

Note: A recording of the Determining Eligibility for CACFP training that was held via Zoom is available on the KSDE Training Portal. This training does include a refresher on completing the Income Eligibility Categories (IEC) summary.





Claim Reminder - Home Sponsoring Organizations Only

September 2024 Sponsor claims must be in "Pending Approval" status by 3:00 p.m. Monday, 10/21/2024. Vouchers will be posted on Tuesday, 10/22/2024, allowing payments to direct deposit on Friday, 10/25/2024. August upward revisions are due by the end of 10/30/2024.

October is Farm to Plate Month!

FY 2024 Farm to School Grant

Child Nutrition Program (CNP) Sponsors may request up to \$10,000 to support Farm to Plate initiatives that will increase the local foods served as part of Child Nutrition Program snacks and meals. Subgrants will be utilized by CNP operators to advance eligible local foods programming activities including gardening, chicken houses, raising livestock, garden towers, and more. Two funding tracks will be available: up to \$2,500 subgrant available for expansion of current farm to CNP projects, and up to \$10,000 for new projects implementing farm to CNP programming. Subgrants will be available to School Nutrition Program (SNP), Child and Adult Care Food Program (CACFP), and Summer Food Service Program (SFSP) sponsors with funding priority given to those with 40% or more of program participants eligible for free or reduced priced meals. USDA Updates

Crediting in the Child Nutrition Programs Tip Sheet Series

The Crediting in the Child Nutrition Programs Tip Sheet series has been revised to reflect the changes with the Final Rule, "Child Nutrition Programs: Meal Patterns Consistent with the 2020-2025 Dietary Guidelines for Americans". The Crediting in the Child Nutrition Programs tip sheet series consists of seven tip sheets covering the five meal components: fruits, vegetables, meats/meat alternates, fluid milk, and grains (three separate tip sheets). The revised versions introduce the menu-planning flexibilities beginning July 1, 2024, and changes that will be implemented in the coming school years in a quick-reference format.

Fiscal Year 2025 CACFP & SFSP Area Eligibility Data Now Available!

The USDA Food and Nutrition Service (FNS) has announced that the 2025 Child and Adult Care Food Program (CACFP) and Summer Food Service Program (SFSP) participant area eligibility data is now available! At the start of every fiscal year, FNS releases a special tabulation of data provided by the Census Bureau for CACFP and SFSP that establishes area eligibility in CACFP and SFSP. This data is effective as of October 1, 2024. The FNS mapping tools have also been updated to reflect the new data.

2024 Summer EBT - Application Deadline Extended to October 15th

The Summer Electronic Benefit Transfer Program (Summer EBT) is a new federal nutrition program that provides grocery benefits during the summer months to families with children eligible for free or reduced price school meals. Kansas has elected to participate in Summer EBT beginning in summer 2024. For more information about Summer EBT in Kansas, go to Summer EBT - Economic & Employment Services (ks.gov). Eligible children that were not automatically issued benefits by DCF by the end of July may complete an online application up until October 15, 2024, at www.dcfapp.kees.ks.gov.
