#### **September Claims Processing**

Child Care Center (CCC) vouchers will resume being posted on the first four Tuesdays of each month beginning with Tuesday, 9/10/2024, allowing payments to direct deposit on Fridays. To ensure timely payments, please make certain Center and Sponsor Claims are in "Approved" status by 8:00 a.m. each applicable Tuesday morning. #### **Claim Reminder - Home Sponsoring Organizations Only**

August 2024 Sponsor claims must be in "Pending Approval" status by 3:00 p.m. Monday, 9/23/2024. Vouchers will be posted on Tuesday, 9/24/2024, allowing payments to direct deposit on Friday, 9/27/2024. July upward revisions are due by the end of 9/29/2024.

#### 2025 Certification

Thank you to those Sponsors who have submitted their 2024 packets for certification in KN-CLAIM. Consultants are currently working through certification documents to approve Sponsors for the 2025 program year in the order they were received. If certification information has not been submitted, sponsors can find instructions for certification at <a href="https://cnw.ksde.org">https://cnw.ksde.org</a>, CACFP, Program Certification. To participate in CACFP for the 2025 Program Year, beginning October 2024, Sponsors must complete program certification requirements as soon as possible to allow sufficient time for review by KSDE consultants. Sponsors cannot claim meals in the 2025 program year until Program Certification is complete and approved by KSDE.

#### **October Claim Reminder - Centers Only**

Centers must report the number of free, reduced price, and paid participants on their October claims. The number of participants in each category is reported in the "Center Income Eligibility Categories" (IEC) section of the Center Claim. Sponsors are required to upload the IEC summary into KN-CLAIM in October and any other month that reported numbers are changed. An Excel version of the Income Eligibility Categories Summary template is available at https://cnw.ksde.org, CACFP, Administrative Handbook, Chapter 12 Claiming Reimbursement.

Reminder: When the claiming percentages are being established for the year, the IEC Summary must only include those participants who have complete and valid enrollment forms on file AND ate a meal/snack in the month of October.

Note: A recording of the Determining Eligibility for CACFP training that was held via zoom is available in the KSDE Training Portal. This training does include a refresher on completing the Income Eligibility Categories (IEC) summary.



#### **Record Keeping Reminders**

- CACFP Records need to be kept for 3 years + the current year. You may discard records older than September 30, 2020. Be sure to shred all Enrollment and Income Eligibility forms and anything that has personal information about the children and parents such as their birthdates, Free-Reduced-Paid status.
- It is not necessary to print KN-CLAIM pages/applications.
- It is recommended to save your monthly claim page. You can print a one page per site report that completely summarizes each claim at KN-CLAIM, Reports, Sponsor Accessible Reports, Center Claim Summary.

#### **USDA Update**

On Monday, August 26, 2024, the USDA Food and Nutrition Service (FNS) released memorandum CACFP 12-2024, SFSP 16-2024, Questions and Answers Related to CACFP 11-2021, SFSP 07-2021, Collection of Race and Ethnicity Data by Visual Observation and Identification in the Child and Adult Care Food Program and the Summer Food Service Program – Policy Rescission -Set 2. This memorandum offers guidance to help State agencies and Program operators comply with the Federal requirement to collect race and ethnicity data from Program participants.

#### **Summer EBT**

The Summer Electronic Benefit Transfer Program (Summer EBT) is a new federal child nutrition program that provides grocery benefits during the summer months to families with children eligible for free or reduced price school meals. Kansas elected to participate in Summer EBT beginning in summer 2024. For more information about Summer EBT in Kansas, go to Summer EBT - Economic & Employment Services (ks.gov). Households can contact the Kansas Department for Children and Families (DCF) at 1-866-369-4777 for more information about eligibility benefits. Eligible children that were not automatically issued benefits by DCF by the end of July may complete an online application up until September 11, 2024, at <a href="https://www.dcfapp.kees.ks.gov">www.dcfapp.kees.ks.gov</a>.

#### **Training Opportunities**

#### **Annual Civil Rights Training**

"Front line staff" and their supervisors must have civil rights training annually. "Front line staff" includes employees who interact with program applicants or participants regarding program services and benefits. Sponsors can use the Annual Civil Rights Training Documentation handout, found in the forms section of Chapter 6 in the Administrative Handbook, and/or go to the KSDE Training Portal at <a href="https://learning.ksde.org">https://learning.ksde.org</a> and select Civil Rights Compliance in Child Nutrition Programs (under Child Nutrition & Wellness, General Classes) to conduct a training session. Be sure to keep documentation of civil rights training on file. Training rosters must also be uploaded annually during Program Certification.





#### **CACFP Monitoring Training**

If you are a multi-site sponsor of centers or a home sponsoring organization, join KSDE for a review of CACFP monitoring requirements and oversight activities. 
#### **CACFP Sponsors Receive Kansans Can Awards**

The Kansans Can 2023-2024 Best Practice Awards were presented by Kelly Chanay, Child Nutrition and Wellness (CNW) director for the Kansas State Department of Education (KSDE), during the Aug. 13th Kansas State Board of Education meeting in Topeka. This is the seventh year for the awards.

**Patterson Family Child Care Center** was recognized for their work to increase access to quality and affordable child care in a high needs area. Patterson Family Child Care has been in operation for 27 years and has been participating in the Child and Adult Food Care Program since 1997. Melissa Patterson and her team were recognized because of their commitment to providing quality, affordable child care in the East Topeka community and therefore increasing access to nourishing meals and snacks through the Child and Adult Care Food Program.

The Opportunity Project and Child Care Aware-Kansas estimate that 44% of children in Shawnee County are without available child care. Patterson Family Child Care Center has stepped up to help meet the need for quality, affordable child care with the recent grand opening of a 2nd child care center for infants and toddlers on August 9th. With the opening of a second child care location in the Highland Park neighborhood, Patterson Family Child Care Center will be able to serve more families in need of affordable, quality child care in high need areas of Topeka and also provide access to nourishing meals and snacks through the Child and Adult Care Food Program. The new center will provide child care for an additional 30 children and was made possible in part by the Topeka Community Foundation and the very hard work of the Patterson Family Child Care Center staff. Congratulations to the Patterson Family Child Care Center team for identifying a need, meeting the need and for making increased access to quality childcare and nourishing meals a reality for the East Topeka community!





The Cathy G. Hudson Envision Child Development Center is one of the Wichita area's most unique child care centers. The center serves both visually impaired and typically developing children in an integrated setting. It is their mission to provide comprehensive early intervention services for children birth through age 5. Teresa Houston, Center Director, shared that at Envision Child Development Center, "We love to encourage farm-to-table experiences. We are able to provide those experiences by partnering with our local farmers with Common Ground Producers and Growers INC and by using our very own herbs from our garden beds."

Children at Envision Child Development Center (ECDC) savor farm-to-table meals, engage in nutrition education activities, and contributed to the creation of the sensory garden at ECDC. Staff at the ECDC, are passionate about encouraging farm-to-table experiences. Every week, the students at ECDC are able to experience farm fresh fruits and vegetables thanks to the center's partnership with Common Ground Producers and Growers Inc. The partnership has enabled a wide range of delicious foods including, but not limited to, cantaloupe, watermelon, onions, cabbage, and eggplant. Children are encouraged to experience foods from the ECDC gardens that were made possible through the collaborative efforts of the Sedgwick County Extension Office Master Gardeners. The Master Gardeners came to ECDC to help the students plant tomato plants and various herbs in the garden beds to create a sensory garden.
