Sunflower Spotlight - Wildwood Outdoor Education Center Pledges "One More"

Wildwood Outdoor Education Center, located in La Cygne, hosts week-long summer residential camps designed to increase summer learning opportunities and diminish the opportunity gap for low-income children. This summer Wildwood pledged to offer "One More" day of service per week and to increase their camper enrollment. Last year, Camp Wildwood was held Monday through Thursday. This year, camp will be Monday through Friday, and campers will receive all meals from Monday's lunch to Friday's lunch. To increase enrollment, Wildwood has partnered with community youth organizations in Kansas City, and they are also offering three weeks of open enrollment (with spots still available), in which any child can attend camp. Wildwood Outdoor Education Center is to be commended for increasing access to summer meals and planning to achieve their "One More" pledge!

New! Monthly Q & A

Volunteers or employees who are directly involved in the meal preparation or meal service at a site can receive a free meal and the meal can be considered an allowable expense to the Summer Food Service Program. Such volunteers or employees are considered Program Adults but meals cannot be claimed for reimbursement.

- **Q:** Are meals served to teachers or volunteers assisting with site activities an allowable cost to the Summer Food Service Program?
- **A:** No, teachers or volunteers would not be considered Program Adults since they are not working directly with the meal preparation or service. Sponsors do have the option to serve meals to anyone and can serve free meals to non-program adults provided the Sponsor uses non-program funds to cover the cost of the non-program adult meals.
