## USDA Area Eligibility Mapping Tool Updated

The USDA Food and Nutrition Services mapping tools have been updated to reflect October 1, 2018 changes. Data from the area eligibility map can be used to establish area eligibility in both the Child and Adult Care Food Program (CACFP) and SFSP. **SP20-2018:** Guidance for Local and State Agencies on 60-Day Claim Submission and 90-Day Reporting Requirements for Child Nutrition Programs – Effective October 1, 2018 USDA has consolidated and clarified longstanding law, regulations, and guidance regarding claim submission and reporting timeframe requirements for Child Nutrition Programs, including the timeline for which final clams must be submitted to the State agency, in what circumstances exceptions and adjustments are allowed, and the State agency's reporting requirements. The guidance is posted at www.kn-eat.org, School Nutrition Programs, What's New.

USDA would like to highlight the following changes included in this guidance:

- All original claims **and** revisions must be submitted by the 60-day deadline. The 90-day deadline for **submission of a revised claim that results in an increase to the amount of reimbursement** has been eliminated. The Sponsors may request approval for a one-time exception every 36 months for one monthly original or revised claim submitted after the 60-day deadline that results in increased reimbursement when the lateness is due to reasons within the control of the Sponsor. The Sponsor must also submit a Corrective Action Plan to correct the conditions that led to the late claim or need for a revised claim.
- Clarifies that if a claim deadline falls on a Saturday, Sunday or a Federal Holiday, the claim due date is the next business day.

#### Sunflower Spotlight – USD 231 Gardner Edgerton

USD 231 Gardner Edgerton operated four meal sites in 2018. A supper site called the Cyclone Café, a pop-up restaurant, was added as a new summer site in 2018. Meals were made to order with a pictorial order form provided on site. The incorporation of the pictorial made-to-order menu allowed the Cyclone Cafe site to accommodate allergy-related dietary needs while giving kids a meal choice. Amy Droegemeier, USD 231 Food Service Director, has incorporated local foods in many of the USD 231 Nutrition programs. Facebook posts include beautiful pictures of local fruits and vegetables that are offered at summer meal service sites. During the school year seasonal menus with a garden bar and Harvest of the Month offerings are available. Amy reports that the food service department has set a goal to procure 15% of all produce from local sources in the next three years.

#### Kansans CAN – Fill the Gap by Offering Year Round Meal Services

Thanks to all the hard work of Kansas SFSP Sponsors Kansas, children have returned to school equipped with healthy bodies and minds. Help students make the grade this school year by serving At-Risk Afterschool Meals to school-aged children in low-income areas. Ensuring that children have access to nutritious meal and snacks when school is not in session is in order for students to achieve both in and outside of the classroom. Qualified sites providing educational or enrichment activities after the end of the school day, on weekends or on holidays during the school year can receive reimbursement at the free rate for all meals/snacks that are served.
