# Local Food for School (LFS) Grant Awarded

The U.S. Department of Agriculture's (USDA) Agricultural Marketing Service (AMS) has signed a cooperative agreement with the Kansas State Department of Education for more than \$2 million to increase the purchase by local School Nutrition Program Sponsors of nutritious, local meats for school meal programs. These products will be healthy and unique to their geographic area, with the goal of improving child nutrition and building new relationships between schools and local farmers.

Through the LFS program, KSDE will allocate funds to schools for the purchase of unprocessed or minimally processed meats from local small business producers, ranchers, and meat processors. This project will pave a way toward a thriving local meat to school infrastructure that can be sustainable after grant funds are no longer available.

The KSDE Child Nutrition & Wellness team will send an email the first week of May to the Authorized Representative with information about the Local Food for School grant, an Attestation Statement with the funding allocation for your Sponsor, a purchase reporting form, and resources to assist in procurement of local meats.

# Child Nutrition Programs: Revisions to Meal Patterns Consistent with the 2020 Dietary Guidelines for Americans – Comments Due by May 10

Based on the latest nutrition science and extensive feedback from our school meals partners, USDA's Food and Nutrition Service is proposing updates to the school nutrition standards in a few key areas to give children the right balance of nutrients for healthy and appealing meals. The proposed updates reflect the goals of the most recent *Dietary Guidelines*, as required by law, and build in plenty of time for planning and implementation to ensure the school meals community and the children they serve are set up for success.



This proposed rule – *Child Nutrition Programs: Revisions to Meal Patterns Consistent with the 2020 Dietary Guidelines for Americans* – is the next step in an ongoing effort toward healthier school meals that USDA and the broader school meals community have been partnering on for well over a decade. # Child Nutrition Programs: Community Eligibility Provision – Increasing Options for Schools-Comments due by May 8, 2023

The rule proposes to expand access to the Community Eligibility Provision (CEP) by lowering the minimum identified student percentage participation threshold from 40 percent to 25 percent, which would give States and schools greater flexibility to choose to invest non-Federal funds to offer no-cost meals to all enrolled students. As a result, more students, families, and schools would have an opportunity to experience the benefits of CEP, including access to meals at no cost, eliminating unpaid meal charges, minimizing stigma, reducing paperwork for school nutrition staff and families, and streamlining meal service operations.

The proposed rule is available on the Federal Register and open for public comment until May 8, 2023. # Questions and Answers #2: Summer 2023 Non-Congregate Meal Service in Rural Areas – SFSP 07-2023, SP 14-2023

This memorandum is the second set of questions and answers on the rural non-congregate summer meals option established through the Consolidated Appropriations Act, 2023 (the Act) (P.L. 117-328). The Act authorized permanent, non-congregate meal service through the Summer Food Service Program (SFSP) and National School Lunch Program (NSLP) Seamless Summer Option (SSO) for rural areas with no congregate meal service. The first memorandum in this series, SFSP 01-2023, SP 05-2023 Implementation Guidance: Summer 2023 Non-Congregate Meal Service in Rural Areas – Revised, was published on February 28, 2023, and is available at

# Best Practices for Contracting with Food Service Management Companies – SP 13-2023

The Food and Nutrition Service (FNS) is pleased to provide a Best Practices memo for School Food Authorities (SFAs) who contract or plan to contract with Food Service Management Companies (FSMCs). This memo is designed to help SFAs think about the procurement process when contracting with FSMCs by walking through the procurement life cycle. It begins with what the SFA should consider before going out to bid, such as what additional contract provisions may be helpful for the SFA, then it discusses what the SFA should do when awarding the contract, monitoring the contract, and addressing changes to the contract, and ends with what to consider if a contract is canceled. # Oversight and Monitoring of the School Meals Program-Guidance on On-site and Off-site Strategies and Options – SP 12-2023

The Department of Health and Human Services recently announced that May 11, 2023, is the planned end date for the COVID-19 Public Health Emergency. Given this expiration date, the FNS-issued nationwide on-site monitoring waivers are set to expire on June 10, 2023, 30 days after the end of the Public Health Emergency. The intent of this memorandum is to provide guidance regarding on-site monitoring and when it is required by regulations. Accompanying this policy memo is an appendix that outlines the review requirements and the on-site and off-site strategies and options applicable to the School Meals Program. Sponsors opting to use the Kansas Online Application for Free and Reduced-Price Meals are not required to complete the Request to Use Electronic Transactions in Child Nutrition Programs form. # Fresh Fruit & Vegetable Program

The application to participate in the Fresh Fruit & Vegetable Program (FFVP) for school year 2023-24 is available at https://cnw.ksde.org, SNP, SNP What's New. The FFVP provides all children in participating elementary schools with a variety of free fresh fruits and vegetables throughout the school year. It is an effective and creative way of introducing fresh fruits and vegetables as healthy snack options. Participation in the FFVP is limited to elementary schools, with priority given to schools with the highest percentage of students eligible for reduced price or free school meals.

To apply for the FFVP, complete the application and return it to KSDE no later than May 19, 2023. Schools selected to participate will be notified in July 2023. # **Food Safety Inspections**

All Sponsors are required to have two food safety inspections each year. If you have not received two (2) inspections by May 1, 2023, you must send a letter to the Kansas State Department of Agriculture (KDA) requesting the needed inspection(s). The date the letter is sent must be recorded on the Site Application during Program Renewal. The annual license fee covers the costs of the two required inspections. Remember that the most recent KDA inspection must be printed and posted in a location visible to the public.

This would allow families to find a location to receive free meals at sites across Kansas.

# Healthy Meals Incentives Grants for Small and/or Rural School Food Authorities (SFA) – Request for Applications

As part of a cooperative agreement to develop and implement USDA Food and Nutrition Service's (FNS) Healthy Meals Incentives Initiative, Action for Healthy Kids is offering competitive grants (up to \$150,000 per SFA) for small and/or rural SFAs to support efforts to improve the nutritional quality of their school meals. The deadline for submitting a grant application is 5:00pm EST, on May 26, 2023. Eligibility Criteria:

- SFA must participate in the National School Lunch Program and/or School Breakfast Program
- SFA must meet the following definitions of small and/or rural:
  - **Small SFA:** SFA with an enrollment of less than or equal to 5,000 students.
  - **Rural SFA:** The majority of students within the SFA are enrolled in a rural school as defined by a locality code of 41, 42, or 43, according to the National Center for Education Statistics online tool.
