- May claim by 07/30/2024
- June claim by 08/29/2024

- July claim by 09/29/2024
- August claim by 10/30/2024

May claims were processed on Tuesday, 6/11/2024, and will not be processed again until the State accounting system re-opens in July. Typically, SFSP vouchers will then be processed the first three Tuesdays of each month as warranted.
