# SFSP Administrative Training - Complete by May 15, 2024

Are you planning to offer meals through the Summer Food Service Program (SFSP) this summer? All new and returning sponsors must have at least one representative complete the SFSP Administrative Training in order to operate the SFSP in summer 2024. The training must be completed by May 15. # Non-Congregate Meal Service in Rural Areas Training - Complete by May 15, 2024

If your sponsor is planning to offer non-congregate meals through the Summer Food Service Program (SFSP) or the Seamless Summer Option (SSO) in summer 2024, at least one sponsor representative must attend the Non-Congregate Meal Service in Rural Areas Training. The training must be completed by May 15. # **Kansas Food Code Updated**

The Kansas Food Code is the regulation that sets the food safety requirements for Food Establishments in Kansas. Based on changes made to the US FDA's Model Food Code and input from various stakeholders, the Kansas Food Code was updated in 2023. # Comment Period Extended for the Interim Final Rule – Establishing the Summer EBT Program and Rural Non-Congregate Option in the Summer Meal Programs

The USDA Food and Nutrition Service is extending the public comment period on the interim final rule, "Establishing the Summer EBT Program and Rural Non-Congregate Option in the Summer Meal Programs," which published in the Federal Register on December 29, 2023. This action extends the public comment period from April 29, 2024, to August 27, 2024, to give the public additional time to prepare and submit comments. The comment period of the interim final rule published April 19, 2024, at 89 FR 28572, is extended through August. To be assured of consideration, written comments on this interim final rule must be received on or before August 27, 2024. The Food and Nutrition Service invites interested persons to submit comments on this interim final rule. Comments may be submitted by any of the following methods: Federal eRulemaking Portal: Go to https://www.regulations.gov. Follow the online instructions for submitting comments. All comments submitted in response to this proposed rule will be included in the record and will be made available to the public.
