# **Community Eligibility Provision – August 31 Deadline to Apply**

All sponsors with at least one site eligible to elect participation in the Community Eligibility Provision will be notified and provided detailed information. # **Community Eligibility Notification Requirement**

Due to the COVID-19 national emergency, KSDE is using proxy data from each Sponsor's information in KN-CLAIM to meet the CEP Notification requirement. Each Sponsor will be provided the data to review in early June so that Sponsors that are interested in applying for the Community Eligibility Provision next school year can update the proxy data to the most current numbers of directly certified students per site. Any updates must be provided to KSDE via the CEP Application in KN-CLAIM by June 30.

# Fresh Fruit & Vegetable Program

The application to apply to participate in the Fresh Fruit & Vegetable Program (FFVP) for school year 2020-21 is available at www.kn-eat.org, Fresh Fruit & Vegetable Program. The FFVP provides all children in participating elementary schools with a variety of free fresh fruits and vegetables throughout the school year. It is an effective and creative way of introducing fresh fruits and vegetables as healthy snack options. Participation in the FFVP is limited to elementary schools, with priority given to schools with the highest percentage of students eligible for reduced price or free school meals.

To apply for the FFVP, complete the application and return it to KSDE no later than May 22, 2020. Schools selected to participate will be notified in July 2020. # **Request to Use Electronic Transactions in the Child Nutrition Program**

Any Sponsor wishing to use an online free and reduced application to determine benefit eligibility must complete and submit to KSDE the Request to Use Electronic Transactions in the Child Nutrition Program (available at www.kn-eat.org, School Nutrition Programs, Food Service Facts, Chapter 7 Related Forms) annually. #### **Food Safety Inspections**

All Sponsors are required to have two food safety inspections each year. If you have not received two (2) inspections by May 1, 2020, you must send a letter to the Kansas State Department of Agriculture (KDA) requesting the needed inspection(s). The date the letter is sent must be recorded on the Site Application during Program Renewal. The annual license fee now covers the costs of the two required inspections. A sample letter is available at www.kn-eat.org, Food Safety. Remember that the most recent KDA inspection must be printed and posted in a location visible to the public.

#### Summer Food Service Program Outreach

All Sponsors are **required** to conduct outreach for the Summer Food Service Program (SFSP). If the Sponsor does not have the SFSP in their school, consider sending the site locator tool link that will be available online home with students or post the link on the school website. #### Administrative Update SY2020-21

SY 2020-21 Administrative Update will be offered via webinars and through an online module. You will be able to choose the option that best meets your needs. Per your requests, targeted webinars will be available for Sponsors of Multiple Child Nutrition Programs (receive the updates for SNP and CACFP in one webinar - no need to attend two as in the past) and RCCIs. Topics will include new policy guidance for SY 2020-21, Annual Civil Rights Training and COVID-19 Contingency Planning. Dates, times and ZOOM links can be found at www.kn-eat.org, Training. Remember, the authorized representative or designee is required to complete this administrative training annually.

Note: In-depth Determining Eligibility (designed for the Determining Official) and Verification training (designed for the Verification Official) will be offered at separate times.
