Updated Seamless Summer Option Reimbursement Rates - Effective January 1st

Waiver authority allows the Summer Food Service Program (SFSP) reimbursement rates for meals and snacks served through the National School Lunch Program Seamless Summer Option for SY2021-22. Summer Food Service Program Reimbursement Rates are updated annually. Rates increased effective January 1, 2022 and are posted at www.kn-eat.org, School Nutrition Programs, Reimbursement Rates.

Supply Chain Assistance Funds - ACTION REQUIRED

To assist School Food Authorities (SFAs) experiencing supply chain disruptions, USDA Food and Nutrition Service has allocated Supply Chain Assistance (SCA) Funds made available through the Commodity Credit Corporation (CCC) and authorized under the CCC Charter Act [15 U.S.C. 714]. The funding allocation for each Kansas SFA includes two components: a base payment of \$5000 and a proportional funding amount based on each SFAs share of statewide enrollment (based on 9/20/21 headcount data). Authorized Representatives for each Kansas Sponsor were emailed important information this week including:

- An Attestation Form indicating the funding allocation,
- USDA Policy Memo SP 03-2022 Allocation of Supply Chain Assistance Funds to Alleviate Supply Chain Disruptions in the School Meals Programs and
- Attachment A which answers frequently asked questions.

SCA Funds cannot be dispersed until the Attestation Form has each attestation statement initialed, is signed and dated (either physically or digitally) and then scanned to KSDE Child Nutrition and Wellness via email to cnw@ksde.org no later than January 31, 2022.

SCA Funds must be deposited in the federal food service account; however, it is not required to account for these funds separately within the non-profit school food service account. SFA's are required to maintain documentation supporting food purchases that are allowable SCA purchases and equal in amount received, consistent with the regular program recordkeeping requirements. When the funds are received (estimated mid-February), please record on Line 8- Federal Grants of the Monthly/Annual Financial Report in KN-CLAIM and deposit in C024 Food Service as 4590 Other Federal Aid.

Frequently Asked Questions from Kansas Sponsors

- **Q.** Do purchases with Supply Chain Assistance (SCA) Funds have to be tracked separately, such as with a spreadsheet and copies of invoices highlighting items?
- **A.** No, purchases do not have to be tracked separately in the food service fund but Sponsors are required to maintain documentation supporting food purchases that are allowable SCA purchases and equal in amount received, consistent with regular program recordkeeping requirements.
- Q: Are local beef processing fees an allowable expense of Supply Chain Assistance Funds?
- **A:** Yes, beef processing fees are an essential incidental cost in the purchase of beef; therefore, Supply Chain Assistance Funds can be used to cover the cost of beef processing fees for beef used as part of the School Meal Program.
- **Q.** Can Sponsors who are contracting with a Food Service Management Company (FSMC) or from another School Nutrition Program Sponsor receive SCA Funds?
- **A.** Yes, USDA has confirmed that School Nutrition Program Sponsors that contract with a FSMC or are in a Sponsor to Sponsor contract can receive the SCA Funds. Sponsors can use the funds to pay their bills as negotiated in the agreement.
- **Q.** How long do Sponsors have to expend these funds?
- A. SCA Funds must be spent by September 30, 2023.
- **Q.** Can we take the SCA Funds if we currently have processed foods such as chicken nuggets on the menu?
- **A.** Yes. By signing the Attestation Statement, the Sponsor agrees that they will purchase unprocessed foods at least in the amount of the grant award but this does not require all processed foods to be taken off the menu.

Annual On-site Accountability Reviews

The School Food Service On-Site Accountability Review (Form 9-G) can be accessed online at www.kn-eat.org, School Nutrition Programs, Food Service Facts, Chapter 9. **By February 1**, **Sponsors implementing the National School Lunch Program including the Seamless Summer Option (SSO)** with more than one serving site must review each site approved to participate in the National School Lunch Program at least once per year and review 50% of all sites approved to participate in the School Breakfast Program once per year. Someone not involved in the daily meal accountability procedures at the site must conduct the On-Site Accountability Review. Keep completed reviews on file with school food service program documents for review or audit. Each on-site review must ensure the school's claim is based on the counting system, as reported on the site application, and yields the actual number of reimbursable meals served for each day of operation. If the review discloses problems with a school's meal counting or claiming procedures, the Sponsor must ensure that the school implements corrective action, and within 45 days of the review conduct a follow-up on-site review to determine that the corrective action resolved the problems. **These reviews can be completed via desk audit this year due to COVID Waiver flexibility.**

Free Online Application for Free and Reduced-Price Meals

A USDA Technology Grant has made it possible for KSDE Child Nutrition & Wellness to develop an Online Application for Free and Reduced-Price Meals. It will be available free of charge to sponsors to use for the 2022-2023 school year. More details regarding the online application system will be provided, including a demonstration, at a Tuesday Townhall in March.
