Summer (Supplemental) 2023 PEBT – Action Needed!

All school-aged students who were eligible to receive free or reduced-price meals at school through the National School Lunch Program at the end of the 2022-2023 school year are eligible to receive the Summer (Supplemental) 2023 PEBT benefit. This list should include students who graduated. All Sponsors are required to complete this excel spreadsheet listing students eligible for Free and Reduced Price Meals at the end of the 2022-2023 school year: Summer 2023 Supplemental PEBT Excel Spreadsheet Template. Include students that were enrolled at the end of the 2022-2023 school year and were Directly Certified, Categorically Eligible or eligible by a Free and Reduced Income Application.

Sponsors must upload their spreadsheet directly to DCF through this secure link: https://www.dropbox.com/request/dnqfFTnB2sgMLqg6BCj0. A box will display with a button saying "Add Files". After clicking the button, the user will have the ability to select the file for upload. When the process is complete, a "Finished Uploading" message will display. **Sponsors can start uploading files now and are encouraged to upload as soon as possible. DCF cannot receive any files after 10/13/2023.** If a sponsor is unable to meet the deadline, those students will not be included in the auto-issued PEBT benefit and will need to apply when the application opens in February. Supply Chain Assistance Funds - Fourth Round

A grant award notification of funding for the Fourth Round of Supply Chain Assistance Funds will be provided to all Sponsors once September 20 enrollment data is audited and made available. USDA has indicated that another attestation statement is not needed if the Sponsor has signed an Attestation previously for Supply Chain Assistance funds. The only action needed will be for those Sponsors who do not want to accept the Fourth Round of Supply Chain Assistance Funds to return the Grant Award notification and indicate they are opting out. More details will be provided during the September Town Hall meeting and in the September Monthly Update.

Child Nutrition Program Integrity Final Rule

On August 23, 2023, USDA's Food and Nutrition Service (FNS) published a final rule, *Child Nutrition Program Integrity*. The final rule impacts the National School Lunch Program (NSLP), School Breakfast Program (SBP), Special Milk Program (SMP), Summer Food Service Program (SFSP), and the Child and Adult Care Food Program (CACFP). The rule finalizes provisions which strengthen program integrity while providing State agencies targeted flexibility to adapt oversight to meet their unique program circumstances. The final rule is available in the Federal Register.

FNS has released SNP 21-2023, "Initial Implementation Memorandum: Child Nutrition Program Integrity Final Rule." This memorandum and attachment provide an overview of the final rule to assist State agencies as they implement the provisions of the final rule. As KSDE learns more about the provisions, information will be provided to you!

Kansas Online Free and Reduced Price Meal Application – Reminder

KSDE has discontinued use of the Barracuda secure email service to deliver the Online Free and Reduced Meal Applications via secure email. You can now download submitted Kansas Online Free and Reduced Price Meal Applications directly from KN-CLAIM, under the Forms tab of the Sponsor Summary. You will still receive an email notifying you that an application is in KN-CLAIM for you to retrieve. After logging into KN-CLAIM, under the Forms tab you will see the following message providing instructions:

"As of July 31, 2023, KSDE is no longer using the Barracuda Secure Email service for delivering online applications for free and reduced-price meals. Submitted applications are now available for download from KN-CLAIM.

How to Use

If you have applications to download, they will be listed below, ordered from oldest to newest. Click on the 'Download' button to retrieve an individual application. Once you have downloaded the application, click the 'Delete' button to remove it from the list. Please note that KSDE cannot recover an application once it has been deleted. KSDE will remove any application that is more than thirty (30) days old."

Excess Cash Balance - Food Service Fund

To maintain the nonprofit status of the Food Service Fund, the fund balance or net cash resources of the fund should not exceed three (3) months' average expenditures. If the balance exceeds this threshold, the sponsor must take steps to reduce the balance or have an acceptable plan for using surplus revenues. **KSDE will notify Sponsors who have exceeded the threshold in September to develop a plan.** The plan must be reviewed and approved by KSDE. Only allowable expenses to the Food Service Fund are approvable. **Due to the uncertainty of costs and participation in school meal programs for SY 2023-24, Sponsors that have excess cash balances will be allowed to indicate that higher food and labor costs paired with lower reimbursement rates and uncertain participation may impact the food service fund and can be used as acceptable reasoning on a spend down plan.**

Annual Civil Rights Training

"Front line staff" and their supervisors must have civil rights training annually. "Front line staff" includes employees who interact with program applicants or participants regarding program services and benefits. Read Chapter 5 in Food Service Facts and/or use the Annual "Front-Line Staff" training handout posted under Resources and Guidance to conduct a training session. Child nutrition professionals can also individually take the online Civil Rights Compliance in Child Nutrition Programs for professional development credit found on the KSDE Training Portal (https://learning.ksde.org). Be sure to keep documentation of civil rights training on file. Training rosters must also be uploaded annually during Program Renewal.

Kansans Can Best Practice Awards 2022-2023

The Kansans Can 2022-2023 Best Practice Awards were presented by Cheryl Johnson, Child Nutrition and Wellness (CNW) director for the Kansas State Department of Education (KSDE), during the Aug. 8 Kansas State Board of Education meeting in Topeka. This was the sixth year for the awards.

Logan USD 326 received the Kansans Can Serve Local Foods Award. They implemented a Farm to Plate sub-grant from KSDE as part of a USDA Farm to School grant. The district's objective was to educate students as to where their food comes from and give them a sense of ownership as they were allowed to grow their own food that was then used for school meals. Logan USD 326 used grant funds to purchase grow lights for garden towers, which allowed students to increase the amount of produce grown. They also purchased a compost bin and a commercial dehydrator. "Logan is a leader in serving local, quality foods in school meals and in teaching students where their food comes from," Johnson said. "They are a mentor and inspiration to many other districts throughout the state showing that Kansans Can serve local foods in child nutrition programs."

DeSoto USD 232 received the Kansans Can Serve Local Foods Award. They celebrated Farm to Fork Friday each Friday from August through October during the 2022-2023 school year. Every Friday, a different local produce item was sourced from local farms and served at lunch through the Kansas City Food Hub – a farmer cooperative wholesaler and retailer that partners with 30 local farmers. Produce served included watermelon, grape tomatoes, sweet peppers, cucumbers, Fuji apples, romaine, and sweet green peppers. Farmer information cards were posted during the lunch meal service so students could see where the produce came from.

Lansing USD 469 received the Kansans Can Impact Wellness award. The district has an active wellness committee that meets regularly. As a team, the committee has set goals to impact wellness within Lansing USD 469. Goals include increasing visibility and interest within the community around creating a healthier school environment and incorporating social-emotional wellness into the wellness policies. "KSDE CNW supports schools in their wellness policy implementation by offering wellness coach visits to school districts," Johnson said. "The wellness coach that assisted Lansing ... was impressed with the work of this diverse community and how their strong policies and practices are truly impacting wellness in the Lansing schools and communities."



Congratulations to Kansas Awardees of the Healthy Meals Incentives Grants for Small and/or Rural School Food Authorities

As part of a cooperative agreement to develop and implement the USDA Food and Nutrition Service's (FNS) Healthy Meals Incentives Initiative, Action for Healthy Kids (AFHK) has announced it is awarding nearly \$30 million in grants to 264 SFAs across 44 states and the District of Columbia. These funds are being provided by USDA FNS. Congratulations to Atchison Public Schools and Burlingame Unified School District for being awarded Healthy Meal Incentive Grants!

Happy 20th Birthday Body Venture

The Child Nutrition & Wellness team is excited to announce the debut of a new and updated Body Venture health education exhibit. This will be the 20th year that the CNW team has made this learning experience available. It started as Body Walk and has had a name change and several makeovers during the 20 years it has been educating students across Kansas, but the message has remained the same – Eat Smart and Play Hard! Lifting Up School Meals

USDA has developed resources to assist School Nutrition Operators to *Lift Up School Meals* during SY 2023-24. Resources include:

- Media Toolkit: Includes videos, social media content, flyers, fact sheets, and b-roll
- School Meals Webpage: Hub for all things school meals
- Support for Schools: Webpage highlighting financial support, such as grants and extra food funds, provided to schools for their meal programs.

Key messages include:

- 1. Nutritious school meals help America's children learn, grow, and stay healthy.
 - School meals are a proven tool for giving kids the nutrition they need for a bright future.
 - School meals are the main source of nutrition for over half of children.
 - Research shows that school meals are the most nutritious food source for American children, thanks in large part to the efforts of school nutrition professionals as well as partners, parents, the food industry, and USDA to best support children's health and wellbeing.
- 2. School nutrition professionals and their partners work tirelessly to ensure children have access to healthy school meals. USDA celebrates their hard work and dedication and remains committed to doing all we can give them the support they need to succeed.
- 3. When all students have access to healthy school meals at no cost, more children are fueled for learning and development.
 - Supporting education is critical for our nation's future; yet research clearly shows that children cannot focus on learning if they are hungry.
 - The nutrition kids receive during the school day is just as important to their future as the lessons they are taught in the classroom. We can't expect kids to learn and achieve if they aren't properly nourished.
 - We need to ensure that nutritious, appealing meals are an integral part of the school day so that every child has the nutrition and energy they need to power their learning.
 - Schools offering healthy school meals at no cost to all students report that it reduces stigma, helps families on the cusp of qualifying, reduces administrative burden, promotes equity, and gives parents financial relief as they manage their food budgets and the many other costs it takes to raise and nurture their children.



- 4. As you're talking to parents directly about school meals, or working with organizations that work with parents directly, it's also an opportunity to flag for them other programs their families might be eligible for.
 - For example, as many of you may know, families have had to renew their Medicaid and CHIP coverage for the first time since the start of the pandemic. Back to School conversations are also an opportunity to make sure families know how to renew their Medicaid coverage.
