Verification

Verification is confirmation of eligibility for reduced price and free meals under the National School Lunch Program and School Breakfast Program. The following sponsors do not complete verification:

- Sponsors participating in ONLY the Special Milk Program
- Residential Child Care Institutions that do not also operate a day school
- Sponsors that are participating district-wide in the Community Eligibility Provision (CEP)

All other sponsors must select and verify eligibility for a sample of applications approved for benefits. One person should coordinate all verification activities for the sponsor. Important deadlines for the verification process are:

- <u>October 1</u> (October 1 is a Sunday, you may count on Monday, October 2 or Friday, September 29) Count applications and students approved for reduced price and free meals. Applications and students that are in "carry-over" status on October 1 are NOT included in this count. Complete the Pre-Verification Worksheet in KN-CLAIM to determine the Sponsor's sampling method. Once the Pre-Verification Worksheet is submitted, go into the Post-Verification Results screen to see the number and type of applications that must be verified. Verify ONLY the number required unless verified "for cause".
- October 31 Update counts of students approved for reduced price and free meals on the Pre-Verification Worksheet in KN-CLAIM. Do NOT update number of applications. CEP sponsors only: Enter the number of students directly certified for Food Assistance (FA) as of 10/31/2023. This total should be the same as row 1a. Enter the total for CEP sites and for non-CEP sites. If sponsor is 100% CEP, put a zero for non-CEP sites.
- November 15 Complete all verification activities. This deadline is the same whether it falls on a weekday or weekend.
- <u>December 15</u> Complete reporting of Post-Verification Results in KN-CLAIM.

To navigate to the Verification screens in KN-CLAIM, select School Nutrition Programs, Program Year 2024 and then click on the "Forms" tab on the Sponsor Summary page. On the same line as "Pre-Verification Worksheet" click the <Add> button which can be found at the right-hand side of the screen and has the image of a + sign. For step-by-step instructions, the Verification Quick Reference Guide can assist you in completing the Pre-Verification Worksheet correctly. Please download the guide at https://cnw.ksde.org, KN-CLAIM, Quick References, School Nutrition Program Verification.

USDA requires KSDE to annually report verification data for each sponsor. The USDA report is completed using the data you provide on the Pre-Verification Worksheet and the Post-Verification Results screens in KN-CLAIM. Please make sure that the information entered is accurate, complete, and submitted on time. Summer (Supplemental) 2023 PEBT – Action Needed by October 13th!

All school-aged students who were eligible to receive free or reduced-price meals at school through the National School Lunch Program at the end of the 2022-2023 school year are eligible to receive the Summer (Supplemental) 2023 PEBT benefit. This list should include students who graduated. All Sponsors are required to complete this excel spreadsheet listing students eligible for Free and Reduced Price Meals at the end of the 2022-2023 school year: Summer 2023 Supplemental PEBT Excel Spreadsheet Template. Include students that were enrolled at the end of the 2022-2023 school year and were Directly Certified, Categorically Eligible or eligible by a Free and Reduced Income Application.

Sponsors must upload their spreadsheet directly to DCF through this secure link:

https://www.dropbox.com/request/dnqfFTnB2sgMLqg6BCj0. A box will display with a button saying, "Add Files". After clicking the button, the user will have the ability to select the file for upload. When the process is complete, a "Finished Uploading" message will display. **Sponsors can start uploading files now and are encouraged to upload as soon as possible. DCF cannot receive any files after 10/13/2023.** If a sponsor is unable to meet the deadline, those students will not be included in the auto-issued PEBT benefit and will need to apply when the application opens in February. Child Nutrition Programs: Community Eligibility Provision – Increasing Options for Schools Final Rule

USDA published a final rule in the Federal Register on September 26,2023, to expand access to the Community Eligibility Provision (CEP) by lowering the minimum identified student percentage (ISP) participation threshold from 40 percent to 25 percent. The rule gives more high-need schools the option to elect CEP and offer all students healthy school meals at no cost when it is financially viable for them to do so. Sponsors using the Online Kansas Free and Reduced-Price Meal Application must print the applications or store them electronically within 30 days of receiving.



Fiscal Year 2023 National School Lunch Program Equipment Assistance Grants

Kansas has received an allocation of \$252,243 to competitively award equipment assistance grants to eligible Sponsors participating in the National School Lunch Program (NSLP) including those operating the Seamless Summer Option (SSO). This year priority does **not** have to be given to high-need schools where 50% or more of the enrolled students are eligible for free or reduced-price meals. Priority will be given to those schools who have not received a previous NSLP Equipment Assistance Grant. These funds will allow Sponsors who apply and are awarded equipment assistance grants to purchase equipment to improve nutritional quality of school meals, safety of food served, increase efficiency of procurement, food storage and service, support expanded participation in the NSLP, ability to use local foods, strategies for adopting lunchroom changes that provide more convenience and appeal to the student population such as Grab and Go or Kiosks and/or to support the establishment, maintenance or expansion of the School Breakfast Program through innovative service models. Supply Chain Assistance Funds Update – Fourth Round

Sponsors will receive a grant award notification of funding for the Fourth round of the Supply Chain Assistance Funds once the KSDE enrollment numbers based on the September 20th count date are available. USDA has indicated that another attestation statement is not needed if the Sponsor has previously signed an Attestation for Supply Chain Assistance funds. The only action needed will be for those Sponsors who do not want to accept the Fourth Round of Supply Chain Assistance Funds to return the Grant Award notification and indicate they are opting out. These funds do not have to be spent by the end of this school year and can remain available until fully used.

Kennedy in 1962, National School Lunch Week (NSLW) was established to promote the importance of a healthy school lunch in a child's life and the impact it has inside and outside of the classroom. - Earning media coverage from local papers, TV stations and bloggers

New to the portal: Pre-Verification Worksheet Tutorial, Post Verification Worksheet Tutorial, and SNP Verification



KSDE Training Portal Tips:

- Portable devices (tablets and phones) do not work well with the portal. Please use a laptop or desktop computer to complete the class.
- Recommended browsers: Microsoft Edge, Firefox or Apple based. The portal does not consistently work well with Google Chrome.
- Close the training each day when finished do not leave the training open. The system will remember where you left off if you close out of the training. Click the "Complete Video Later" or "Exit Activity" button (top right) rather than just closing the browser.
- If there is a problem with connectivity while watching a video, exit the module immediately. Refresh the screen once connectivity is re-established and re-enter the video.
- The connection between the video and the reporting system is a lot like a phone call if something happens to disrupt the signal, the connection needs to be re-established. If you don't, you can keep talking but the other person doesn't hear you. In the training portal system, if the connection breaks, you can keep participating, but the system doesn't know you are still there for that activity and will not register completion.

Local Foods Culinary Training – Coming in October!

Celebrate Farm to School Month by participating in the Local Foods Culinary Training. Available in October on the KSDE Training Portal, this 2-hour training features Kansas products and producers, gives helpful information to how to implement Farm to Plate in Kansas Child Nutrition Programs, and provides recipes and culinary tips for incorporating the Kansas products featured in the training into local menus! Each school kitchen with a staff member completing the training is eligible to receive a culinary toolkit consisting of dough cutter, wire whisk, digital scale, and blender (1 kit per school kitchen). 2023 Farm to School Census

The U.S. Department of Agriculture Food and Nutrition Service (USDA FNS) is gearing up for the 2023 Farm to School Census! FNS has contracted with Decision Information Resources (DIR) and Mathematica to conduct the Census with all public, charter, and private school food authorities (SFAs) that participate in the National School Lunch Program (NSLP) nationwide. Your full participation is crucial to ensure that the Census data is representative of all SFAs in the country and in your State.

On October 2, 2023, DIR will e-mail you a link to the Census and instructions. It will come from Farm2SchoolCensus@dir-online.com. Please add this email address to your approved senders list so that you don't miss the email. When completing the Census, you will provide information about your SFA for school year 2022-23. You will have through December to complete the Census.

Additionally, in the email with your Census link, you will also receive an invitation to a webinar open to all SFAs that will provide an overview of the Census, guidance on filling out different sections, and an opportunity to ask questions about the Census. We encourage your attendance to learn more about this important research effort.

Responding to FNS research requests is required under the National School Lunch Act, and it is important that **all SFAs participate**, **regardless of their participation in farm to school activities**. The Farm to School Census is our best tool for collecting important information to help us support your farm to school efforts. If you are curious about how your results will be used, you can see the results of the 2019 Farm to School Census at https://farmtoschoolcensus.fns.usda.gov/census-results-overview. You can explore data at the SFA, State, or national level.
