#### **September Claims Processing**

School Nutrition Program (SNP) vouchers will resume being posted on the first three Tuesdays of each month beginning with Tuesday, 9/10/2024, allowing payments to direct deposit on Fridays. To ensure timely payments, please make certain Site and Sponsor Claims are in "Approved" status by 8:00 a.m. each applicable Tuesday morning. Fresh Fruit & Vegetable Program (FFVP) claims will be vouchered on Tuesday, 9/24/2024, allowing payments to be directly deposited on Friday, 9/27/2024. Claims will then be vouchered 1-2 times per month throughout the school year. #### **Summer EBT**

The Summer Electronic Benefit Transfer Program (Summer EBT) is a new federal nutrition program that provides grocery benefits during the summer months to families with children eligible for free or reduced price school meals. Kansas has elected to participate in Summer EBT beginning in summer 2024. For more information about Summer EBT in Kansas, go to Summer EBT - Economic & Employment Services (ks.gov). Households can contact the Kansas Department for Children and Families (DCF) at 1-866-369-4777 for more information about eligibility benefits. Eligible children that were not automatically issued benefits by DCF by the end of July may complete an online application up until September 11, 2024, at www.dcfapp.kees.ks.gov.

#### **Important - Medicaid Direct Certification!**

Only students found on the Direct Certification list as eligible for free or reduced price meals due to Medicaid can be directly certified. A Medicaid number submitted by a household on a paper or online application cannot be used to certify students for free or reduced price meals because not all Medicaid programs meet Child Nutrition Program Income Eligibility Guidelines.

If a student was initially approved for free benefits through an application, TAF, MED-F, or Foster status but is later found on the direct certification list as FA, the POS accountability system needs to be updated to show free benefits based on FA.

#### **Direct Certification with Medicaid Q&As**

**Q:** A household says they are eligible for Medicaid and should be receiving free or reduced price meals, but I know they have to be on the direct certification list. Who should I have them contact to see why they are not on the list?





**Q:** If a student is on the Direct Certification list as MED-R, but the family goes ahead and completes an application because they believe they are eligible for free meals based on income and are determined eligible for free, would they receive free meals instead of reduced?

**A:** Yes, if the household completes an income application and qualifies for free, they would receive free benefits based on the income application and the income application would be included in the verification pool.

**Q:** Can a Medicaid Number be accepted on an Income Application and used to certify students for Free Meals?

**A:** No. Not all Medicaid programs meet Child Nutrition Program Income Eligibility Guidelines. Only students found on the Direct Certification list can be certified for free or reduced meals based on Medicaid.

#### **Indirect Cost Rates**

Indirect Cost Rates for 2024-2025 have been posted at https://cnw.ksde.org, SNP, What's New. Food service uses the unrestricted rate in the last column. Please note that non-public Sponsors use the de minimis rate which has increased to 15%.

#### **Excess Cash Balance - Food Service Fund**

To maintain the nonprofit status of the Food Service Fund, the fund balance or net cash resources of the fund should not exceed three (3) months' average expenditures. If the balance exceeds this threshold, the sponsor must take steps to reduce the balance or have an acceptable plan for using surplus revenues. **KSDE will notify Sponsors who have exceeded the threshold in September to develop a plan.** The plan must be reviewed and approved by KSDE. Only allowable expenses to the Food Service Fund are approvable. Due to the uncertainty of costs and participation in school meal programs for SY 2024-25, Sponsors that have excess cash balances will be allowed to indicate that higher food and labor costs and uncertain participation may impact the food service fund and can be used as acceptable reasoning on a spend down plan.

#### Verification

Verification is confirmation of eligibility for reduced price and free meals under the National School Lunch Program and School Breakfast Program. The following sponsors do not complete verification:

- Sponsors participating in ONLY the Special Milk Program
- Residential Child Care Institutions that do not also operate a day school
- Sponsors that are participating district-wide in the Community Eligibility Provision (CEP)

All other sponsors must select and verify eligibility for a sample of applications approved for benefits. One person should coordinate all verification activities for the sponsor. Important deadlines for the verification process are:

October 1 – Count applications and students approved for reduced price and free meals.
 Applications and students that are in "carry-over" status on October 1 are NOT included in
 this count. Complete the Pre-Verification Worksheet in KN-CLAIM to determine the
 Sponsor's sampling method. Once the Pre-Verification Worksheet is submitted, go into the
 Post-Verification Results screen to see the number and type of applications that must be
 verified. Verify ONLY the number required unless verified "for cause".



- October 31 Update counts of students approved for reduced price and free meals on the Pre-Verification Worksheet in KN-CLAIM. Do NOT update number of applications. CEP sponsors only: Enter the number of students directly certified for Food Assistance (FA) as of 10/31/2024. This total should be the same as row 1a. Enter the total for CEP sites and for non-CEP sites. If sponsor is 100% CEP, put a zero for non-CEP sites.
- November 15 Complete all verification activities. This deadline is the same whether it falls on a weekday or weekend.
- <u>December 15</u> Complete reporting of Post-Verification Results in KN-CLAIM.

To navigate to the Verification screens in KN-CLAIM, select School Nutrition Programs, Program Year 2025 and then click on the "Forms" tab on the Sponsor Summary page. On the same line as "Pre-Verification Worksheet" click the <Add> button which can be found at the right-hand side of the screen and has the image of a + sign. For step-by-step instructions, the Verification Quick Reference Guide can assist you in completing the Pre-Verification Worksheet correctly. The guide is available at https://cnw.ksde.org, KN-CLAIM, Quick References, School Nutrition Program Verification.

USDA requires KSDE to annually report verification data for each sponsor. The USDA report is completed using the data you provide on the Pre-Verification Worksheet and the Post-Verification Results screens in KN-CLAIM. Please make sure that the information entered is accurate, complete, and submitted on time. ### **Culinary Coaches - NEW Training Program!**
